

#### THE GOVERNMENT OF THE KYRGYZ REPUBLIC

#### ORDER

No. 141 of March 29, 2019

On approval of the Plan of the Government of the Kyrgyz Republic for 2019-2023 to implement the program of activities of the Government of the Kyrgyz Republic, approved by Jogorku Kenesh of the Kyrgyz Republic on April 20, 2018 № 2377-VI

In order to implement the Program of the Government of the Kyrgyz Republic "Unity. Trust. Creation", approved by the Decree of the Jogorku Kenesh of the Kyrgyz Republic on April 20, 2018 № 2377-VI, in accordance with articles 10 and 17 of the constitutional law of the Kyrgyz Republic "On the Government of the Kyrgyz Republic" Government of the Kyrgyz Republic.

DECREES:

1. Approve:

- Plan of the Government of the Kyrgyz Republic for 2019-2023 for the implementation of the program of activities of the Government of the Kyrgyz Republic according to Annex 1;

- National investment projects implemented within the framework of the Program of the Government of the Kyrgyz Republic, in accordance with Annex 2.

2. Establish that at the end of each year the indicators of the Plan of the Government of the Kyrgyz Republic for 2019-2023 may be adjusted.

3. The Ministry of Economy of the Kyrgyz Republic shall prepare annual action plans of the Government of the Kyrgyz Republic for the relevant years within the framework of the Plan of the Government of the Kyrgyz Republic for 2019-2023, one month before the beginning of the next calendar year.

3. State executive authorities of the Kyrgyz Republic, offices of authorized representatives of the Government of the Kyrgyz Republic in the regions, local authorities (as agreed) to take comprehensive measures to achieve the indicators of the Government Plan of the Kyrgyz Republic for 2019-2023.

4. Establish personal responsibility of heads of state executive bodies of the Kyrgyz Republic, authorized representatives of the Government of the Kyrgyz Republic in the regions, heads of local governments (as agreed) for quality and timely achievement of the indicators of the Plan of the Government of the Kyrgyz Republic for 2019-2023.

5. The relevant departments of the Office of the Government of the Kyrgyz Republic shall be responsible for monitoring the implementation of this resolution.

6. This Decree shall enter into force after ten days from the date of its official publication.
